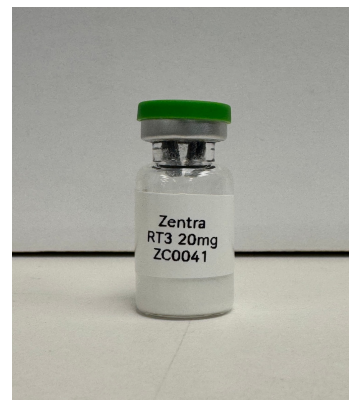

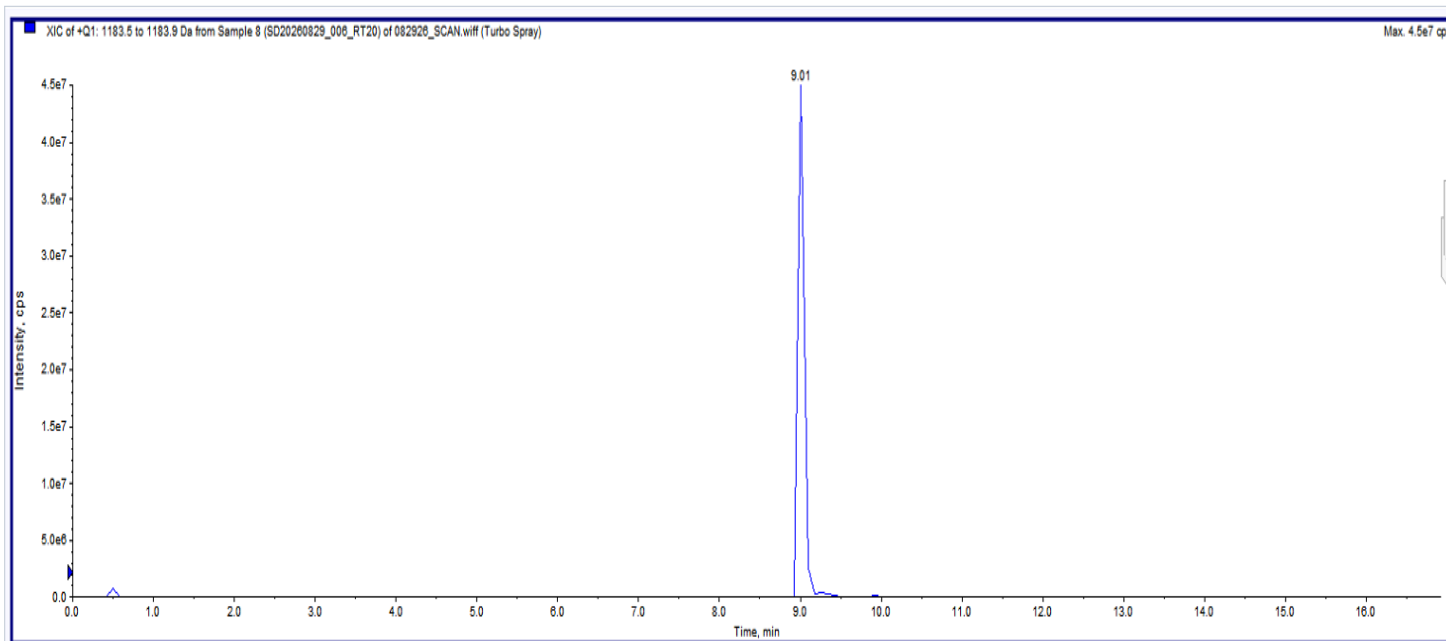

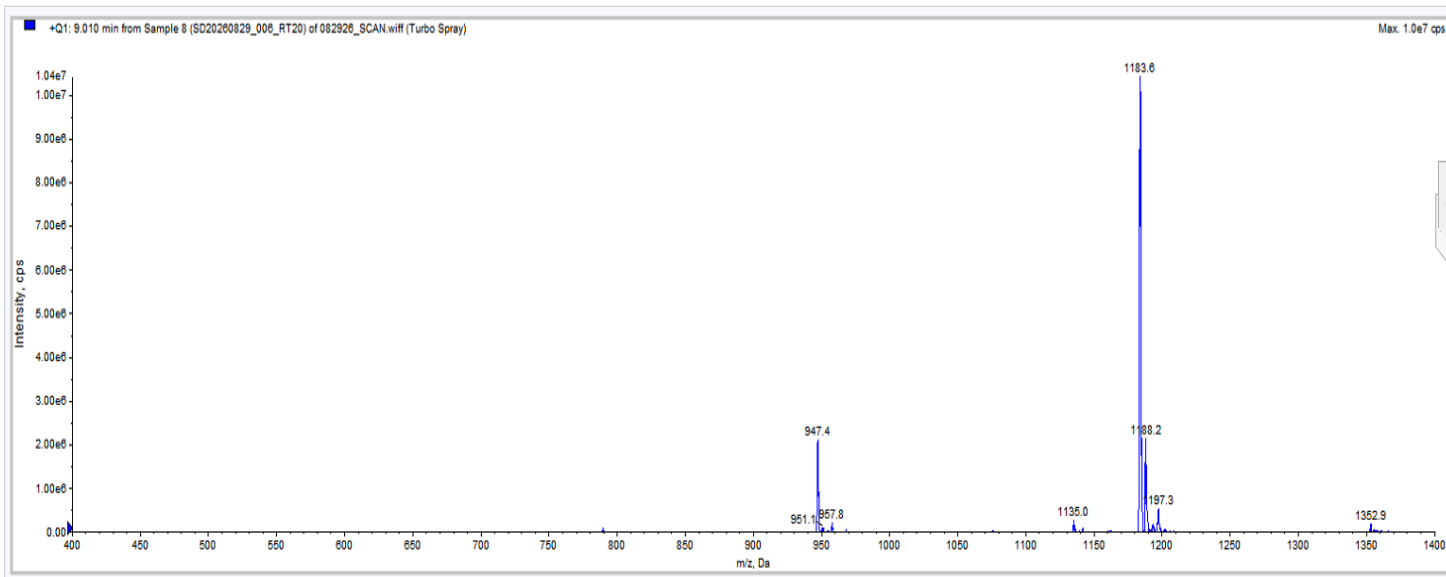

ANALYTICAL INTERPRETATION

Retention Time Match

Mass Spectrum (LC-MS)

LC-MS analysis of the submitted Retatrutide sample produced a single dominant precursor ion at $m/z \approx 1183$ Da, with minor associated peaks between 1188–1206Da. The retention time was approximately 8.9 minutes, consistent with the expected elution window for this compound under standard chromatographic conditions.

The spectral profile confirms the presence of a single major species corresponding to the Retatrutide molecular ion, with no significant secondary peaks indicative of impurities or degradation products. The data supports the compound identity and purity within the limits of the LC-MS method.
